Sub: Defaming and Targeting employee leaving real conspirators knowingly corporate communications regarding suspicious transaction found in credit adjustment report.

Kindly take the reference of above cited letter issued from your good office & corporate Office alongwith report from PGM SM UPE. In the report dated 29/11/2022 which is duly forwarded to your good office following findings were forwarded for consideratation.

- 1. The unauthorized fraudulent transaction happened by Hacking of Employee user id and creating transaction rights inadvertently on the User-ID of CRO which were meant only for viewing rights (Refer paragraph-14).
- 2. The beneficiary were already identified and informed (refer paragraph-7) namely

M/s Saini Network.

M/s Cellcampus.

M/s Varnaval.

- 3. Above beneficiaries were questioned and after giving Fishy answers they just left free without lodging FIR then and their (refer paragraph-15).
- 4. From entire report it may easily be concluded that M/s Pyro is involved in Creating all nuisance i.e. Creating all India transaction rights on view only CRO id, non-providing satisfactory responses, Non providing such report for ATD/ATC, Non providing reconciliation reports in time.
- 5. Such fraud was caught and money was recovered due to exceptional effort of Sri Amar Maheshwari and Shri Arvind Chandra within 5 days of discovery. Refer very 1st point in ATN summary.

But it is observed that all the **corporate correspondence** is made without considering the report findings and this has resulted very negative impact on such exceptional employee working for the interest of BSNL and had very negative impact en-mass in BSNL. The correspondence has resulted as below.

- 1. The employees who otherwise would have been rewarded for safeguarding BSNL (as Whistle blower) by revealing fraud and causing recovery to stop loss, were being suspended and punished (refer Point 4 of ATN Summary).
- 2. Mentioning employee Pernor/HRMS no. is proved to be a defaming and derogating activity against employee who has performed his duties and safeguard BSNL.

SUBSTICHEN, WE

- 3. Non quoting that "This was an unauthorized fraudulent transaction happened by Hacking of Employee user id and creating Transaction rights inadvertently on the User-ID of CRO which were meant only for viewing rights "in corporate correspondence and putting it on intranet is suspicious and against employee only.
- 4. Non mentioning Beneficiary M/s Saini Network, M/s Cellcampus, M/s Varnaval and conspirator M/s pyro in any of corporate correspondence is showing clear favoring of this parties who caused harm to BSNL.
- Non-questioning on Non-lodging of FIR till against above beneficiary and main conspirator pyro in any of corporate correspondence is showing clear favoring of this parties who caused Harm to BSNL.
- Non removal of suspension and continuous targeting even after report by The PGM SM UPE is serious act against employee concern and had very negating impact on all the employee of BSNL.

SNEA as association is of the firm view that such derogative act against the employee and favorable with vendor is not tolerable. This should be condemned and corrigendum must be issue to restore the negative impact on employee mindset on BSNL employees working for the interest of BSNL only.

After going all the fact and finding of the report, it is requested that suspension of Sri Amar Maheshwari, AO and Shri Arvind Chandra, SDE is not at all justified and must immediately be revoked. It is requested that FIR must be lodged against beneficiaries and legal action must be initiated immediately against beneficiaries and conspirator found in report.

Report on Unauthorized Transaction found in agent adjustment report from PYRO in UP(East) Circle

UPE circle is having a user id 199800988 for making any agent adjustment. Sh. Arvind Chandra, SDE (Sales) is the only authorized officer for making agent adjustment. Shri Arvind Chandra is the Circle Nodal Officer for UP(East).

The Last Agent adjustment report prior to 27th October 2022 report was fetched in the Month of June 2022, (Copy attached-Annexure-I) no unauthorized agent adjustment transaction observed in June 2022 agent adjustment report .Agent adjustment report was not fetched in July ,August and September 2022 as no big amount agent adjustment request received from field units.

On Ist October 2022 Hamirpur OA SDE(Sales), Shri Rajan Gautam submitted in his mail for adjustment of Rs 15000 in CTOP Nos 7839933767 for Rs 5000 each wrong topups done on 9532900860, 7839933767 & 9455932713 CTOP Numbers. SDE (IN) UP East Sh 5000 each from Rs Atul Kumar requested for deduction of 9532900860, 7839933767 & 9455932713 CTOP Numbers. IN team Chandigarh reported on 28th October through email that these top up amounts have been deducted from all three numbers.

As this amount was transacted wrongly from Master CTOP no 7839933767(Instead CTOP Value it gave Talk time worth Rs 5000 in three CTOP Nos mentioned above) for reverting it back to Master CTOP Number agent adjustment was to be done to the master number. Before doing this adjustment in the October agent adjustment report was downloaded from 1/10/2022 to 27/10/2022 as a precaution for record purpose. It was observed in this report that a Rs 50000 agent adjustment done on CTOP Number 8765468466 belonging to M/s Varanval Comm, Deoria OA on 20/10/2022, without knowledge of CNO. This was the trigger point for raising alarm about fraudulent transactions. Seeing this Agent adjustment report From 1/7/2022 to 27/10/2022 was also downloaded.

On Analysis of this report from 1/7/2022 to 27/10/2022, unauthorized agent adjustment as per detail given in Annexure-II was observed.

Immediately after finding the discrepancy Mr Rajesh of M/s Pyro was contacted on 27/10/2022 at phone number 9888707530 by CNO Shri Arvind Chandra by his mobile 9450920411,to give details of these unauthorized transactions . M/s Pyro reverted back through email on 27/10/2022(Mail Copy attached-Annexure-III) giving details of user ID and IP Addresses .The user IDs and IP Addresses were being analyzed by UPE Sales team, but could not get concluded. On 1st Nov 2022 the IP Addresses mentioned in mail Dt 27/10/2022 were blocked by M/s Pyro on their own without any request from UPE Circle CNO/CRO. The user ID 201002615 had been created with viewing rights to make daily sales report and the related

reconciliation work. The statement of the user ID 201002615 Sh Amar Maheshwari is attached as Annexure-IV

Nodal Centre Chandigarh and Corporate Office New Delhi were intimated about the unauthorized transactions on 3/11/2022 and 4/11/2022 respectively for taking preventive measure by Nodal Centre to avoid future repetition of similar transactions.BA Heads of Gorakhpur and Faizabad were requested to get deposited the fraudulent amount from erring channel partners at the earliest vide letter no UPE/S&M/General/2022 Dt 5/11/2022.

Total unauthorized credit amount in UP(E) is Rs 23,53,813/- is as per detail given below

- 1. M/s SAINI NETWORK Rs.1442256/- (Gonda),
- 2.M/s Cell CampusRs.686395 & M/s SAINI NETWORK (Basti)Rs122680/-.
- 3. M/s Varnaval Communication Rs.102482/-(Deoria).

In Compliance to Letter no no UPE/S&M/General/2022 Dt 5/11/202The channel partners taken ctop up value of Rs27,28,533/- during 5th Nov 2022 to 9th Nov 2022as per details given below-

- 1.M/s SAINI NETWORKRs.17,93,700 (Gonda),
- 2. M/s Cell Campus BastiRs.685826/-(Rs 2717 balance already exist in master Ctopup)
- 3. M/s SAINI NETWORK (Basti)Rs1,23,448/-.
- 4. M/s Varnaval Communication(Deoria)Rs.125559/-

The amount of Rs 23,53,813 has been adjusted against the fraudulent transaction on 18/11/2022 (Annexure-V). from CTop values taken during 5th Nov 2022 to 9th Nov 2022.

M/s Pyro in its mail Dt 9/11/2022 intimated a second user ID no 200302492 involved in unauthorized stock movement and intimating ,it belongs to Raebareli OA.

A letter UPE/Sales/S&M/General/2022/4 Dt 11/11/2022 was sent to Nodal Centre refuting the claim of 2nd ID not belonging to UPE after checking from our own record .On checking HRMS number 200302492 on ERP server it was found that this ID no 200302492 pertains to Assam circle in the name of Swapan Kumar Sarkar (RM).It appears that this user has been created with the mala fide intention from somewhere else or from Pyro's end for doing unauthorized transaction.

In reply to our Letter no UPE/Sales/S&M/General/2022/4 Dt 11/11/2022 M/s Pyro intimated in its mail Dt 15/11/2022 that this ID 200302492 belongs to Mr Ajeet, SDE Sales of Raebareli OA.After checking from our own record it is observed that the ID of Raebareli OA is 200302491 & the same was intimated to M/s Pyro on 16/11/2022 through mail. The reply of M/s Pyro is awaited. Nodal Centre has been requested to give details about user ID 200302492 ,under whose approval this ID was created vide letter no UPE/S&M/General/2022 /8 Dt 25/11/2022 by M/s Pyro .

M/s Pyro in letter no PYRO/HPL/BSNL/NZ-UPE/22-23/11-02 Dt 9/11/2022 addressed to AGM(IN) Mohali (Copy enclosed-Annexure-VI) giving details about all debit and credit transactions done through user ID 201002615 and 200302492. This letter was forwarded on 16/11/2022 by



DGM(Finance) UP(East) Circle to Shri Amar Maheshwari CRO. In this letter it is observed that 42 Debit Credit transactions done through user ID 201002615 and 7 Debit ,credit transactions done through user ID 200302492. 16 Debit and 5 Credit transactions were done outside UP East Circle in Haryana, Punjab, UP West and Uttranchal Circle while 21 Credits and 7 Debits were done in UP East.

GM(Nodal Centre) Chandigarh has been requested to give details of order under which the privileges for inter Circle transactions were allowed vide letter no No. UPE/S&M/General/2022/9 Dt 26/11/2022 (Copy Attached Annexure-VII)

The user id 201002615 pertains to CRO Shri Amar Maheshwari, is shown in the agent adjustments report submitted by M/s Pyro in its report Dt 9/11/2022 but as per the corporate office order 2-3/2013 /RM-CM/BSNL /Part-II Dt 22/6/2018 CRO is only responsible for getting report from CNO and NRO for the CTOP reconciliation. Hence this user id has never been used for the agent adjustment(Statement of Sh Amar Maheshwari Annexure-I may be seen). Also as per delegation of activities ,user was never required to do so. In order to further corroborate this point Nodal Centre was requested to give details about the log of the user id & the rights given to the user in the letter dated 11/11/2022 to ascertain that a CRO is given agent adjustment right under whose approval .The user was to be created with viewing rights only as CRO login in the circle. The user id: 201002615 has been used at three different IP locations at GPO Lucknow, Basti BA and Laplace building Lucknow,. This situation is suspicious since the user was available in person at Lucknow office and never visited Basti or GPO on the transactions date, neither he shared the password(As per Statement of CRO-Annexure-I) .Also since user was with CRO role only the question of transactions does not arise . Thus it seems to be system breach or hacking by somebody else. The detail of the MAC id in order to identify the physical address has also been requested in the letter to Nodal Centre, Chandigarh but M/s Pyro in its reply Dt 15/11/2022 stated that MAC ID is not captured in ctop up server .In the absence of MAC ID exact location of fraud cannot be ascertained at our end.

Meanwhile, Shri Rakesh Kumar Saini, Owner of M/s Saini Network and Cell Campus were called at Lucknow for giving his side of details on 10/11/2022. Mr Rakesh Kumar Saini did not give anything in the writing and also failed to turnup next day for further enquiry. He said that this money was transferred from unknown source to his CTOP Number involved. Similarly, Sh.Avanish Barnval who was called to Lucknow on 15/11/2022 for giving his statement, stated that he has received the amount from unknown source in his sub agent ctop up number. He said he has already deposited the money and same may be adjusted against unauthorized transactions on his part.BA Heads of Gorakhpur and Faizabad have been requested to take written statement for the fraudulent transaction vide letter no UPE/S&M/Gen/2022/7 Dt 22/11/2022(Annexure-VIII)

For CtopUp Reconciliation:

The CTOP up reconciliation from April-2020 to Mar-2022 has not been received from Pyro's /NRO end to UP East Circle. M/s Pyro has been requested to send all the previous reconciliation statement through email on 15/11/2022 The reconciliation report for April 22 received on 4th October 2022, and reconciliation report for May 22 and June 22 received on 10th October from M/s Pyro. Reconciliation report for July 22 was received on 11th Oct and Aug 22 report received on 27/10/2022. All





these reports were received through email from M/s Pyro. Primary Sale reconciliation was always done by CRO on monthly basis with utmost care without noting any discrepancies.

The agent adjustment report down loaded by the CNO Shri Arvind Chandra for the period 1/7/2022 to 27/10/2002 has 28 Debit Credit entries without the knowledge of CNO.Month wise agent adjustment details for UP(E) are as under

- 1. July: 2 Transactions
- 2. Aug:19 Transactions
- 3. Sep:6 Transactions
- 4. Oct:1 Transactions

Total 28 Transactions

In the reconciliation report of July (Annexure-IX)only One transactions of Rs 51000/- Dt 29/7/22 was reported while no reference is available for second transaction of Rs 122679/- Dt 19/7/2022. Thus M/s Pyro reconciliation report for July report failed to correctly report all transaction.

Similarly the August reconciliation report(Annexure-X) does not mentioned any agent adjustment transactions, where as in Aug 19 unauthorized transaction in UP(E) were reported in PYRO GUI report downloaded by CNO Sh Arvind Chandra on 27/11/2022. Here also M/s Pyro reconciliation report for Aug 22 failed to reflect correct reconciliation report.

CTOP up reconciliation reports received from M/s Pyro for July and August 2022 does not capture the correct picture of inter circle agent adjustments which was visible only in the statement submitted by M/s Pyro letter Dt 9/11/2022.

CRO was supposed to receive monthly reconciliation report for preceding month in the next month, which was never received in a timely manner.

Had these corrected reports been received from M/s Pyro or NRO in the month of Aug-22 (for Jul-22) with correct details of inter circle transactions details, this unauthorized transaction could have been detected in the month of August itself.

M/s Pyro has been requested to share Sept-22 & Oct-22 reconciliation on phone. The report is yet to be received.

Reason for delayed reporting of Suspicious Amounts credited in UP(East)

UP(East) Circle is not having any access for seeing the stock movement done in other Circles.

Huge amount of stock moved through unauthorized means from UP(West), Punjab, Haryana & Uttranchal Circle to UP(E) CTOP up Numbers . The details of some of the high value transactions of these Circles are as under

A. In Haryana Circle Rs 122679.85 debited from CTOP of Ambala OA on 19/7/2022 to UP(E) CTOP Number. Ist unauthorised transaction.



- B. In Punjab Circle Rs 52482 debited from CTOP of Sangrur OA on 24/9/2022 to UP(E) CTOP Number
- C. In Uttranchal Circle Rs 125469.21 debited from CTOP of Nainital OA on 7/8/2022 to UP(E) **CTOP Number**
- D. In UP(W) Circle Rs 186000 debited from CTOP of Budaun OA on 7/8/2022 to UP(E) CTOP Number

This type of unauthorized transaction can be brought to notice by either of the following

- The affected CTOP Number through which money is siphoned off reports to Sales team/concerned officer in the OA for the mishap.
- The respective CRO/CNO of the concerned Circle reports either to Nodal Centre or UPE
- NRO of Nodal/Pyro by sending correct reconciliation report

None of the above concerned officer/person escalated the matter at any level till, the matter was escalated by UP (E) team to Nodal Centre and Corporate Office .Event after issuance of corporate office letter no BSNLCO-FICM/16 (11)/1/2022-FIN CM Dt 7/11/2022 none of the affected circle CNO/CRO or Nodal Centre NRO reported about unauthorized transactions of CTOP amounts siphoned off from respective Circle CTOP Numbers to UP(E) Ctop Numbers .Similarly it was expected in the security of Pyro software to reject any transactions which was not in the assigned domain (In this case UPE Circle) of the user .The debit and credit amount of UP(E) should also be rejected by Pyro software security as CRO is not supposed to do agent adjustment. It failed to prevent in both cases .Only CNO is allowed to do agent adjustment as given in the details of Para-III of this report on page-1. After the intervention of corporate office M/s Pyro reported all Debit and Credit Transaction through its letter PYRO/HPL/BSNL/NZ-UPE/22-23/11-02 Dt 9/11/2022. Thus UP(E) Circle users had never a chance for detection of such transaction on their own with the available routine reports.

Place of incident of the above unauthorized transactions was at other Circle, UP(E) has only reciprocated with the corrective measured and ensured recovery in the interest of BSNL and avoided any Cash loss in this incidence.

Action taken by UP East team to avoid any repetition of such recurrence & recoupment of the undue credit adjustments:

- 1. Money involved has been recovered and cash loss to BSNL has been saved due to exceptional efforts of CRO Shri Amar Maheshwari and CNO Shri Arvind Chandra .Total money got deposited within Five days from 5/11/2022 to 9/11/2022.
- 2. Action against the identified channel partners was taken by blocking the tree of the involved channel partners worth Rs 5 lacs.

- 3. The BA Heads of Faizabad and Gorakhpur have been requested to put M/s Saini Network, M/s Cell Campus and M/s Varnaval Communication under suspension and make arrangement for look after as per S&D Policy.
- 4. As per Corporate Office Letter no. BSNLCO-FICM/16(11)/1/2022-FIN CM Dt 24/11/2022 Shri Arvind Chandra CNO and Shri Amar Maheshwari AO(Sales)/CRO has been placed under suspension.(Copy of suspension letter attached Annexure-XI and XII)
- 5. Through Nodal Centre Chandigarh M/s Pyro has been requested to give details of all functional GUI agent adjustment report from 1/1/2021 to October 2022 , in order to ensure that no other GUI is involved in unauthorized transactions.
- 6. Case has been handed over to GM(Vigilance) UP(East) for detailed investigation(Annexure-XIII).

I had never been requested to provide the agent adjustment privilege in best of my knowledge. I have never shared my password for Pyro User to anybody else.
- 2. The user id: 201002615 has been used at three different IPs (10.108.2.198, 10.114.97.235, 10.108.3.140) where as the user has never shared his password to anybody else. This indicates to the system breach or user id being hacked by somebody else. The MAC id in order to identify the physical address of the computer has been asked from Nodal Center & but Pyro in its reply dated 15.11.2022 stated that Ctop up system does not capture the Mac Id.
- 3. Agent adjustment sub- menu was never visible in my login.
- 4. I have never done any inter-circle agent adjustment as well as agent adjustment pertaining to UP East circle from my user id. It was not there in my role of CRO since CNO is having agent adjustment rights in UP East.
