This officiating promotion will not confer any right upon them for regular absorption in grade of SDE (Telecom). The service rendered on ad-hoc/ offg. promotion will not count for the purpose of seniority etc.

This local officiating arrangement will be automatically terminated on joining of regular incumbents or expiry of 180 days, whichever is earlier. Also this arrangement is likely to continue beyond 30 days but not beyond 180 days.

This officiating arrangement is on purely temporary and on local officiating basis and can be terminated at any time without assigning any reason.

After expiry of the officiating period of 180 days the concerned officers will work in their substantive capacity of JTO in the same SSA / Unit where they have been officiating as SDEs till further orders.

Before relieving the concerned JTOs on promotion for joining their new assignments, the controlling officers should ensure that no disciplinary/vigilance case is pending or contemplated against them and that they are not undergoing any punishment. Such cases may be reported to this office promptly.
