We further bring to your kind notice that many SDEs of QA Mankapur and QA Naini, Allahabad were transferred to UP(East) Circle by Corporate Office New Delhi vide letter no. 1-2/2009-pers-II dated 28.04.2009 & CGM QA Bangalore letter no. ST-3/1-3/PP/7 dated 20.06.2009. But **SDEs of QA Mankapur and QA Naini, Allahabad have not been relieved by GM QA New Delhi well in time in the interest of their QA unit due to their work load.** Unfortunately all of sudden, the GM QA New Delhi have issued a letter for the relieving of SDEs of QA Mankapur and QA Naini, Allahabad on **21.10.2009**, in the mid - education session clearly **violating the BSNL Transfer Policy.**
